

TERMS AND CONDITIONS OF PARTICIPATION

******* PLEASE READ THE RULES AND REGULATIONS CAREFULLY*******

1. **LOCATION:** The event will be staged at the Kendall Showgrounds Batar Road Kendall.
2. **DATES & TIMES:** The event will be open to the public on the Saturday and Sunday of the Show. Hours as follows: Saturday 8 am till late, Sunday 8 am till 6pm.
3. **ELECTRICITY/CONTRACTORS:** Only electrical contractors appointed by the Organisers may run power or connect equipment within the event. Power will be available to limited sites only. Exhibitors are responsible for their own leads for connection.
Any Exhibitor intending to bring electrical equipment to the Showground will be required to ensure that such equipment is fitted with earth leakage circuit breakers and that all electrical leads, tools and appliances have been inspected and tagged by a licensed electrical contractor.
This is essential for the safety of yourself, your fellow exhibitors and the general public and is a requirement of the Occupational Health and Safety Act of 1983. The Act imposes severe penalties in the event of non-compliance with its provisions. Any exhibitors who do not comply will not be allowed to exhibit at the Kendall Showground.
Please check all your electrical equipment and leads before you come to the Showground to avoid the occurrence of any difficulties.
4. **AUTHORITY:** The Exhibitor agrees to accept all requests and directions made by the Organiser at all times.
5. **PAYMENT:** Unless specifically authorised in writing, no Exhibitor may occupy the rented space unless full payment has been made by the given date. This includes delivery of goods, attendance by contractors of any other activity on the contracted area.
6. **SETTING UP AND DISMANTLING:** The ground and buildings will be available for setting up from 7:00am to 4:00pm on Friday. All stands are to be completed by 8:00am on Saturday. Dismantling is not to be commenced before 4:00pm on Sunday.
7. **INSURANCE:** All insurance must be with an authorised Australian insurer as approved by APRA. Please include a photocopy of your Certificate of Currency for \$20m or include a compulsory fee of \$40 to cover the Exhibitors Public Liability Insurance for \$20 million.
8. **RESPONSIBILITY:** Whilst all care will be taken, the Organiser accepts no responsibility for the security of Exhibitor's goods or materials on site at any time. Insurances on the display area are the responsibility of the Exhibitor.
9. **DISCLAIMER:** The Organiser is specifically absolved by this Agreement from responsibility or any claim for loss or damages or re-imburement or for any other entitlement due to cancellation, failure to perform or any other reason or cause which is beyond the control of the Organiser, including weather, industrial actions, riots or acts of war.
